- If a corporation is not incorporated by registration or an association without juridical personality, the address which is provided in documents or statements submitted to a tax office is described.
- If a corporation is a foreign corporation or the like which has a place of business or office in Japan, the address provided in documents or statements submitted to a tax office or the address of tax representative is described.

In the “Corporate Number (13-digit)” section, the designated 13-digit Corporate Number is described.

The information as displayed on the National Tax Agency’s Corporate Number Publication Site is described in the information displayed on the “National Tax Agency’s Corporate Number Publication Site” section.

Since the JIS third and fourth level letters or nonstandard letters may not be entered from or displayed on personal computers used by users, the letters in a registered trade name and address are replaced with the JIS first or second level letters in advance so that they will be properly displayed on the “National Tax Agency’s Corporate Number Publication Site.” For example, the letter “恣” is replaced with “法.”

In this case, the letters which cannot be replaced with the JIS first or second level letters are replaced with “\_ (underbars).”  
(Note) The Basic 3 Information of an association without juridical personality or the like will not be published without the prior consent of its representative or manager. The fact that there are descriptions in this section does not mean that the information will be published.

The information in the “Person Who Has Been Designated Corporate Number” section is based on the registered information on incorporation in the possession of the National Tax Agency as of the date of preparation of the notice described in the upper right part of the notice or the information notified to a tax office or the like (hereinafter called the “Registered Information”).

- In the “Trade Name or Name” section, the trade name or name in the register or reports is described.
- In the “Address of Head Office or Principal Place of Business” section, the address of the head office or principal place of business in the register or documents submitted to us is described.

- In the “Address of Principal Place of Business or the Like in Japan” section, the address of office or place of business in Japan is described if the person who has been designated the Corporate Number is a foreign corporation or the like (a corporation which does not have a head office or principal place of business in Japan).

(Note) If you wish to confirm the registered matters with respect to the registered information described in this section, please contact the competent registry office with which you have filed an application for registration

“NTA” is printed in the top and bottom margins of the notice (in 12 places each) with special ink.  
(Note) “NTA” is the abbreviation of the National Tax Agency.
